

# NOTICE OF APPLICATION FOR RECTIFICATION

## APPLICATION FOR THE RECTIFICATION OF UNLAWFUL COMMENCEMENT OR CONTINUATION OF A LISTED ACTIVITY IN TERMS OF SECTION 24G OF THE NATIONAL ENVIRONMENTAL MANAGEMENT ACT, 1998 (ACT NO. 107 OF 1998), AS AMENDED.

Notice is given, in terms of Section 24G read together with Section 24F of the National Environmental Management Act (NEMA), 1998 (as amended) (Act No. 107 of 1998) and Section 24G Fine Regulations, that an application for the Rectification will be lodged with the Mpumalanga Department of Agriculture, Rural Development, Land and Environmental Affairs (MDARDLEA) by Safe Sail Trading (Pty) Ltd for commencement of activities associated with accidental encroachment, without the necessary environmental authorisation, onto a Park Erf and a small sections of a wetland on Erf 63 of Thulamahashe Township B, Mpumalanga Province.

**Project Name:** Wetland and Park Erf Encroachment Thulamahashe

**Proponent:** Safe Sail Trading (Pty) Ltd

**Project & Property Description:** This application for rectification is for areas of accidental encroachment onto a Park Erf and small sections of a wetland which is located within the Park Erf, known as Erf 63 of Thulamahashe Township B, Mpumalanga Province.

**Location:** The area of encroachment is situated within a Park Erf along the northern and eastern boundaries of the Thula Mall Shopping Centre, which is located at the corner of Thulamahashe to Rolle Road and Acornhoek Road, Thulamahashe Township B, Mpumalanga Province.
